Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Section 45 of the Mental Healthcare Act, 2017 (Central Act No. 10 of 2017) provides that every State Government shall, within a period of nine months from the date on which the said Act receives assent of the President, by notification, establish an Authority to be known as the

State Mental Health Authority. Government have established State Mental Health Authority vide notification issued under G.O. (P) No. 87/2019/H&FWD dated 16th July, 2019 and published as S.R.O. No. 486/2019 in the Kerala Gazette Extraordinary No. 1651 dated 19th July, 2019, and G.O. (P) No. 6/2020/H&FWD dated 29th February, 2020 and published as S.R.O. No. 170/2020 in the Kerala Gazette Extraordinary No. 761 dated 4th March, 2020. Now Government have decided to nominate Non-official members of the Authority by amending the said notification.

The notification is intended to achieve the above object.
